Natasha is also an award-winning and New York Times best-selling author. She has two upcoming novels: I, MONA LISA is publishing in 2022 with Hutchinson Heineman and THE BONE ROAD is publishing 2023 with Polygon. Her debut, MR ROSENBLUM'S LIST, was published by Spectre in July 2010 to critical acclaim. It went on to be an international bestseller, was translated into ten languages and Natasha was subsequently shortlisted for 'New Writer of the Year' at the Galaxy Book Awards 2010. Her second novel, THE NOVEL IN THE VIOLA, was published by Spectre in the UK in May 2011, and was chosen for Richard and Judy's 'Summer Book Club' that year. The book was subsequently published by Penguin (Plume) in January 2012 as THE HOUSE AT TYNEFORD. Natasha's third and fourth novels were published by Spectre; THE GALLERY OF VANISHED HUSBANDS, was published in July 2014, and THE SONG COLLECTOR, was published in summer 2015. Her latest, HOUSE OF GOLD was published by Hutchinson Heineman in May 2018.
